Volunteer Agreement for BTCA-HEART Rescue Dog	

This agreement is made and hereby entered into on this _____ day of _____, 20__ by _____ and between BTCA-HEART, hereafter referred to as "HEART", and _____ (rescue volunteer contact name), hereafter referred to as "Volunteer" for the temporary care of rescued dogs and puppies awaiting adoption, hereinafter referred to as Rescue Dog.

Both parties agree to the following terms of Volunteer care:

Volunteer agrees to provide temporary care to any rescue dog (male or female) that comes into HEART's dog rescue program. Breed: _____ Bedlington Terrier _____.

Volunteer understands and agrees that they will give temporary care to the Bedlington Terrier or other dog assigned by the HEART Rescue Coordinator. The Volunteer agrees to assist the HEART Rescue Coordinator with record keeping, appointments, public information, etc. if needed. Volunteer agrees to refer to the rescue dog (him or her) by the name of record and by no other name either publicly or privately.

Volunteer agrees to keep this dog as an indoor companion and to keep this dog in a fenced yard or on a leash at all times when outside. Volunteer agrees not to leave this dog unattended outside either tied up or in a fenced yard when no one is home. Volunteer agrees secure the rescue dog safely when transporting by vehicle.

Volunteer agrees to provide this dog with proper food, water and loving attention. Volunteer understands that any food

receipts for reimbursement must be submitted ASAP to BTCA-HEART. We ask that you use the same food diet rescue dog came with if possible.

Volunteer agrees to either bring this dog to veterinary appointments, adoption day events, spay or neuter appointments or to allow BTCA-HEART to make alternate transportation arrangements for these appointments and events to ensure his/her well being and find him/her a forever home. Volunteer understands that all puppies will be spayed or neutered prior to adoption at the age recommended by a veterinarian approved by BTCA-HEART.

Volunteer agrees to allow people HEART has approved to meet the dog at their home or at another location nearby. Volunteer agrees to facilitate these meetings and answer questions by prospective adopters. Volunteer agrees to return phone call or email messages from HEART Rescue Coordinator within 24-48 hours.

All items on any Volunteer Addendum are included under the terms of this contract.

Volunteer understands that HEART retains legal control of this dog and Volunteer is not authorized to make any legal or medical decisions on his/her behalf. This includes agreeing to administer any medications to the Volunteer dog as directed by HEART and/or their veterinarians. If Volunteer does not wish to administer any medications as directed they must contact HEART immediately. HEART retains the right, in its discretion, for any reason, to retain physical possession of the animal at any time. Volunteer agrees to release the Volunteer dog to HEART upon written demand.

Release of Liability

I/We understand that all rescue volunteer work done with BTCA-HEART is at my/our own risk. _____ (Initial).

I/We, _____ have read, understand, and agree to abide by the conditions of the BTCA-HEART Volunteer Agreement. I/We understand that all work done with BTCA-HEART is at my/our own risk and fully, irrevocably and unconditionally release and agree to hold harmless BTCA-HEART and its individual members from any and all known or unknown, anticipated or unanticipated, suspected or unsuspected and/or fixed, conditional or contingent actions causes of actions, charges, suits, debts, demands, claims, contracts, covenants, liens, rights, liabilities, losses, royalties, costs, expenses (including, without limitation, attorney's fees) or damages, including but not limited to any medical costs, damages to property, persons or other pets, of every kind, nature and description, at law or in equity, in connection with or arising from while I am caring for the agreed rescue companion animal.
